


The U.S. ETF market added 14 products during February despite an ongoing global correction in stocks triggered by the coronavirus outbreak that began in China.

The pace of 26 new ETPs launched through the first two months of 2020 compared to the 32 in 2019, represents a 19% year-over-year (YOY) decline. Looking ahead, product issuers are facing a difficult climate for introducing new ETPs.

Among February's most active issuers was Direxion Investments, which launched three ETFs including the well-timed release of the **Direxion Flight to Safety Strategy ETF (FLYT).** The fund combines exposure to just three asset classes – gold, utilities, and long-term U.S. Treasuries. The idea is to provide asset protection to areas minimally correlated with stocks.


For February, the CBOE Global led all stock exchanges with seven new ETP listings while NYSE Arca added six and Nasdaq grabbed one. ■
